



Safety Revolution Scholarship Application Information 2022/23

Who can apply?

The Safety Revolution Scholarship is open to **2nd year BSc** or **1st year FdSc** students who are interested in pursuing a career with Safety Revolution.

Only students eligible to work in the UK should apply.

Opportunities

Safety Revolution **may** award up to three scholarship(s) and if awarded, the successful recipient(s) will receive:

- A significant contribution towards their education of **£6,000** in the year prior to placement
- Paid employment with Safety Revolution during their placement year
- There will be opportunities to join Safety Revolution as a graduate health & safety consultant

The award will be paid in two equal parts; half to be paid in February 2023 and the remaining balance in May 2023.

Payment is conditional on the scholar(s) remaining registered as a full-time student at Harper Adams. They must pass all modules of study during the continuation of the scholarship and submit a letter of thanks for the sponsor to the Development Trust prior to the receipt of each payment. A condition of your scholarship is that you undertake your placement year with Safety Revolution.

This is a competitive award which will be evaluated on the merit of the submitted application, academic achievements to date and interview. The Development Trust embraces diversity and promotes equality of opportunity and access to higher education. The Trust has been successful in supporting a wide range of students. It strongly encourages applications from students of all backgrounds. Where there are two applicants of equal merit, preference will be given to applicants who are from backgrounds that are underrepresented in UK higher education.

The decision of the Safety Revolution Scholarship Panel is **FINAL** and they reserve the right to withdraw the award at any time should they feel this action is required.

Application Process

Your application must include the following 3 documents, which will need to be saved in PDF format:

1. **A covering letter**, which should be no more than 2 pages and should include the following information
 - Why you have selected to study your chosen course
 - Why you believe that you should be considered for the Safety Revolution Scholarship
 - What your career plans are upon graduation
2. **Full CV** – no more than 2 pages
3. **Consent Form** – this must be completed and signed to show that you have read and understood the Privacy & Data Protection Notice

Please note - you may ONLY apply for a maximum of 3 placement based scholarships

Should your application be successful you will be required to decide whether or not to accept the scholarship offered within 24 hours; failure to do so in the designated time period may result in the offer being withdrawn by the sponsor.

How to submit your application:

- 2) Log in with your usual network ID and password
- 3) Click on the **Placements** box
- 4) Click on the **Placements with Scholarships** box
- 5) Select the placement you're interested in and click the **Start Application** button
- 6) Follow the on screen instructions to complete your application
