The Loxley Scholarship Application Information 2023/24

This scholarship is offered by Loxley, a specialist law firm advising on all aspects of property law, with a particular emphasis on rural land and agricultural businesses. The firm was created in response to the diverse needs of owners and occupiers of land and those working in the rural sector.

Who can apply?

This scholarship is open to all **2nd & final year BSc students** enrolled on a full-time Land and Property Management course, Agriculture with Farm Business Management or Environmental Land Management at Harper Adams University.

The Scholarship

Loxley Solicitors Ltd may award one scholarship **valued at up to a maximum of £2,000.**

The award will be payable in two equal parts; half to be paid in March 2024 and the balance in May 2024. Payment is conditional on the scholar remaining registered as a full-time student at Harper Adams. They must pass all modules of study during the continuation of the scholarship and submit a letter of thanks for the sponsor to the Development Trust prior to the receipt of each payment.

This is a competitive award which will be evaluated on the merit of the submitted application and academic achievements to date. The Development Trust embraces diversity and promotes equality of opportunity and access to higher education. The Trust has been successful in supporting a wide range of students. It strongly encourages applications from students of all backgrounds. Where there are two applicants of equal merit, preference will be given to applicants who are from backgrounds that are underrepresented in UK higher education. The decision of the Loxley Solicitors Scholarship Panel is **FINAL** and they reserve the right to withdraw their award at any time should they feel this action is required.

Application Process

Your application must include the following three documents, which should be saved in PDF format, named 1 Consent Form, 2 Answer and 3 CV and emailed to DevelopmentTrust@harper-adams.ac.uk by **12 noon on Wednesday 31 January 2024**. Email subject: Loxley Scholarship

Note that there will be no interviews for this scholarship, and a decision will be made by the sponsor based on the content of the application.

1. **Consent Form** – this must be completed and signed to show that you have read and understood the Privacy & Data Protection Notice
2. **Answer to question set by the sponsor** – in a document of no more than two A4 pages, give your answer to the following question:

“Tenant farmers holding tenancies pursuant to the Agricultural Holdings Act 1986 or the Agricultural Tenancies Act 1995 face a disadvantage, when compared to freehold owners, in their ability to benefit from farm diversification and also Environmental Land Management Schemes.’ Discuss the veracity or otherwise of this statement.”

3. **CV** – no more than **two pages**
